

# Sea freight - import / export Air freight – import / export

Full Container Load FCL / Less then Container Load LCL -We cooperate with our partner agents and network all over the globe moving cargo FCL or LCL via air or sea, into or from Europe.



#### **Short-Sea**

Full container or trailer transportations between any European ports are performed regularly via short sea vessels for certain destinations with cost concern and efficiency in mind.

For example, cargo are often loaded into container to move from Rotterdam in Holland to Gdynia port in Poland via short sea vessel – especially when the number of containers is large.

#### To Door Container delivery – Train / Barge / Truck / Trans-loading

Direct transportation from discharging port to final destination anywhere in Europe – for example using barge to terminals near the final destination or using train service to move containers to a train terminal nearby the final destination or moving containers into a warehouse near the discharging port, discharge cargo and load onto a trailer for transportation to the final destination so there will be no more concern with return of empty container; or a simple direct container trucking from discharging port to final destination. We could even arrange special agreement with the train or barge terminal nearby the final delivery destination where additional free storage days would be allowed or at a discounted rate to ease storage problems and slow down and extend the actual transit time efficiently - should this be required at any time.

**TGI** is currently operating a 7000 sq m bonded warehouse with security class IV (the highest in Europe) in Rotterdam port area since 2002 and with a third party operated warehouse near Zaltbommel with capacity up to 14000 sq m.

#### Distribution

**TGI** provides distribution for clients who use the TGI warehouse and those who have their own warehouse as well as pick up and delivery of cargo to and from any third party warehouse from their suppliers or customers. We do not only liaise with our customer but their customers too! 


